Model Oil Portfolio

We have created a portfolio of oil stocks with a focus on recovery and growth.

NOTE: *The Model Oil Portfolio has a longer-term perspective. As such, we will update it once a week, using Friday's closing prices. Also, it will be essentially a Buy-and-Hold portfolio, with minimal trading involved.*

The initial investment will be a total of \$300,000. To begin with, we chose and purchased just seven stocks, with each having an initial position of approximately \$10,000. As this Portfolio is created, the Energy sector looks particularly weak. The respective stock charts are not pretty. Cash comprises 77% at the outset.

COMMENT: *The Portfolio changed very little again this past week, falling just 0.2%. It is surprising that the Energy sector did not respond positively after the OPEC+ announcement that their members and associates will continue to curtail production for at least the next nine months. There is hope that the USA and China will resolve their trade/tariffs dispute fairly soon, which would be positive (one would think) for the Energy sector. Accordingly, we will be looking for the right opportunity either to add new names to the Portfolio or to add to existing positions ... again, if things are right.*

COMMENT: *Although there are now four stocks trading at prices below the First Sell price, because these stocks are so volatile they could move substantially higher on any positive catalyst such as the USA/China trade/tariffs dispute being resolved.*
